SIDE LETTER AGREEMENT
EQUIPMENT MECHANIC WAGE RATES**

Whereas, the City of Chico (“City”) and the Service Employees International Union (SEIU), Local 1021 reached a Memorandum of Understanding (“MOU”), effective January 1, 2022 through December 31, 2024; and

Whereas, the City and SEIU have agreed that recruitment and retention issues exist for qualified Equipment Mechanic II employees; and

Whereas, the City and SEIU have agreed that a wage adjustment will assist in attracting and retaining qualified candidates for the Equipment Mechanic II position; and

Whereas, the City and SEIU have agreed to adjust the base wage rate for Equipment Mechanic II as follows, with the approval of City Council:
