The Bargaining Team shall be made up of the President, Robert Mitchell, with five elected representatives and one alternate.

*Challenges to or disputes arising from this election must be submitted in writing to the Chapter Election Committee within three (3) working days after the committee submits its written election report to the Chapter Executive Board. The committee shall respond within five (5) working days of the receipt of the challenge. Challenges or disputes which are denied or cannot be resolved by the Chapter Election Committee may be appealed in writing to the Local 1021 Chapter Executive Board within five (5) working days of receipt of the Chapter Election Committee's decision. The Local 1021 Chapter Executive Board shall investigate and respond within fifteen (15) working days of receipt of the challenge. Challenges to the election will be considered valid only if they cite specific violations of the Chapter election rules and procedures, Chapter bylaws, or the Local 1021 Constitution and if the alleged violation may have affected the outcome of the election.*
