Side Letter of Agreement between

The Superior Court of California County of Amador

The Service Employees International Union, Local 1021 General Employees Representation Unit

The Superior Court of California, County of Amador (Court) and Service Employees International Union, Local 1021, General Employees Representation Unit (Union) enter into this Side Letter of Agreement and hereby agree to the following:

(1) Meaning and Effect

Unless otherwise stated, the financial provisions of this Side Letter of Agreement (regarding wage and classification schedules, medical plan contribution levels and cash in lieu amounts – referred to as the "Side Letter") supersede any inconsistent, conflicting or redundant provisions of the parties' Memorandum of Understanding, October 1, 2015 through September 30, 2018 (referred to as the "MOU"), and all of the parties' subsequent side letters of agreement entered into by the parties between 2018 to present.

(2) Waiver of the Right to Reopen the MOU and Extension of MOU Term

In consideration for the Union's agreement to: (a) waive its right to reopen the MOU, and (b) extend the parties' MOU via Side Letter for an additional one (1) year, through September 30, 2026, the Court agrees to the following:

- (a) A 5% base wage increase effective the first pay period following execution of this Side Letter (see attached <u>Exhibit A</u>, revised wage and classification schedule, incorporated herein by reference);
- (b) The addition of "Step G" to the wage and classification schedule (see attached Exhibit A), effective January 1, 2025;
- (c) An increase to Court medical plan contribution levels and cash in lieu amounts, effective the first pay period following execution of this Side Letter. The Court shall increase cash in lieu contributions for employees in the represented unit to \$337.50 per pay period (\$675.00 per month). The increase to medical plan contributions is memorialized at Exhibit B, incorporated herein by reference; and
- (d) The provisions of the parties' MOU and the Court Personnel Manual otherwise remain in full force and effect except that the parties shall negotiate amendments to the non-financial components of the MOU. It is the parties' intent to revise the non-financial components of the MOU to reflect updates in current law, to remove inconsistencies between the Personnel Manual and the MOU, and to reflect non-financial best practices, to be negotiated in good faith by the parties.

(3) Term of Side Letter

This Side Letter shall become effective upon the date of execution of this Side Letter. The provisions of this Side Letter shall terminate on September 30, 2026.
